Does Alstom have a KA24 gas turbine? On 13 September, Alstom announced the launch of its upgraded GT24 gas turbine and the corresponding KA24 combined cycle power plant offering for North America, parts of Latin America, Asia and the Middle East (60Hz market).

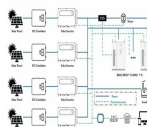

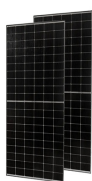

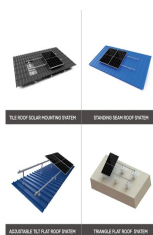
