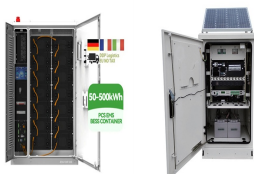

As of 2019, less than 1% of Trinidad and Tobago's energy came from low-carbon sources. In 2020, BP, Shell, and Lightsource won a bid to provide grid scale renewable energy throughout Trinidad and Tobago. In 2021, the Trinidad and Tobago Solar Energy Market was projected to grow from 3 MW of solar power in 2020 to approximately 184 MW by 2026.

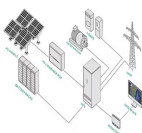

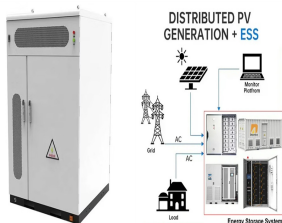
