What is the British Indian Ocean territory? The British Indian Ocean Territory (BIOT), is an overseas territory of the United Kingdomsituated in the Indian Ocean halfway between Tanzania and Indonesia, and directly south of the Maldives.

The territory is an archipelago of 58 islandscovering 56 square kilometres (22 sq mi). The largest island is Diego Garcia, which at 32.5 square kilometres (12.5 sq mi) accounts for about half of the territory's total land area.



In 2022, British Indian Ocean Territory exported a total of \$5.8M, making it the number 221 exporter in the world. During the last five reported years the exports of British Indian Ocean Territory have changed by -\$11.7M from \$17.5M in 2017 to \$5.8M in 2022.
