Where is Avangrid constructing the first large-scale offshore wind project? Avangrid as part of a 50-50 Joint Venture with Copenhagen Infrastructure Partners, is constructing the first large-scale offshore wind project in the United States, Vineyard Wind 1. The project is located 14 miles south of Martha's Vineyard, off the coast of Massachusetts.



What is Avangrid doing with New England wind? Avangrid is also developing the New England Wind 1 and New England Wind 2 projects. Combined, New England Wind 1 and 2 offer the region 1870 MW of clean, reliable offshore wind power, enough to power nearly 1 million homes and reduce emissions by nearly 4 million U.S. tons, equivalent to taking 700,000 cars off the road annually.



Where is Avangrid located? The project is located 14 miles south of Martha's Vineyard, off the coast of Massachusetts. The project is currently under construction, and will deliver clean energy to 400,000 homes and businesses in the Commonwealth. Avangrid is also developing the New England Wind 1 and New England Wind 2 projects.

The US Bureau of Ocean Energy Management concluded its environmental review of Avangrid's 2.6GW New England wind project in February 2023. In the same year, the company and its partner Copenhagen Infrastructure Partners installed the first turbine at the 806MW Vineyard Wind 1 offshore wind farm.



The US Department of the Interior has approved Avangrid's 2.6GW New England Wind offshore wind farm, the country's eighth commercial-scale offshore wind energy project.. It will be located 20 nautical miles south of Martha's Vineyard and 24 nautical miles south-west of Nantucket, Massachusetts.
