After Hurricanes Irma and Maria pummeled the Virgin Islands in 2017, causing people to flee and businesses to close, the utility's peak electric demand fell by half.

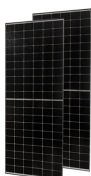

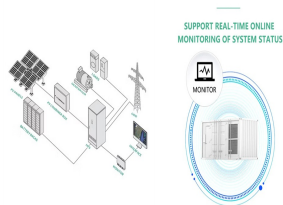
