Can a foreigner buy a property in Beijing? Foreign nationals with work or journalist visas, who are working in China and do not own a home, can buy one property in Beijing for personal residence. The homebuyer applies for a Home Purchase Eligibility Review. Both parties of the transaction sign a purchase agreement. Both parties submit the necessary materials for the property transfer.



Should foreigners buy property in China? Most foreigners, who plan to stay in China for long, are thinking of purchasing their own property after seeing how the housing market has been performing so well and the fact that the quality of Chinese residential property is surging.



Can I buy a house in China? According to the regulations on the access and administration of foreign investment in real estate, foreign individuals working or studying in China can purchase a house for personal residential purposes based on their actual need.



How many houses can a foreigner buy in China? The number of houses that can be purchased by a foreigner in China is no longer regulated to a maximum of one. A mandatory rule is that foreigners use the acquired property only for residential purposes and not for renting purposes or other activities. An important aspect is that the new legislation is available for Chinese mainland.



Can a foreigner buy a house in Shanghai? The legislation applicable in Shanghai also states that a foreigner without a household registration is allowed to purchase only one property. In Beijing, foreign persons would be permitted to buy a house if they pay social security and taxes for five years before the purchase.

What should you consider when buying property in China? Another thing to consider about timing and buying property in China is that the property market, in many respects, moves faster than in Western countries. Because Chinese often pay in cash, the process is generally faster than in countries where the majority of properties are purchased with loans and mortgages.

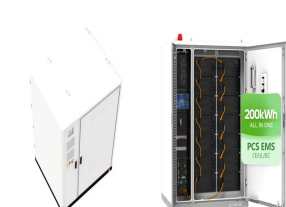
