How to start an energy storage facility in Poland? When considering starting an investment as an energy storage facility, it is necessary to apply the Energy Law, which contains regulations for this type of installation. The main regulatory obligations in Poland depend on the total installed capacity of a given storage facility .



How do energy storage projects work in Poland? The operational stage of a storage project also typically involves a process of support agreements such as O&M contracts, technical consulting, and power distributor agreements. Projects concerning energy storage, as with other infrastructure projects in Poland, require the necessary administrative permits to be obtained.

Do energy storage facilities need a power grid? Regarding the regulatory issues, it should be borne in mind that each energy storage facility must be connected to the power grid, thus it must abide by the rules of the power grid, which are called the Distribution Grid Operation and Maintenance Instructions.

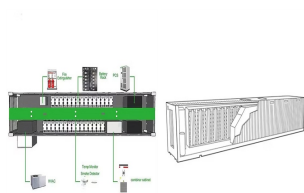

The draft parameters for this year's capacity market auction in Poland could make the rollout of battery energy storage systems (BESS) much more difficult. The document proposes a significant reduction to the BESS derating factor that could be particularly harmful for longer duration storage systems.



State-owned power company PGE Group has obtained regulatory approval to build a 200MW/820MWh battery energy storage system (BESS) in Poland. The project, called CHEST (Commercial Hybrid Energy Storage), will target a capacity of no less than 200MW and a power output of 820MWh, making it one of the largest in Europe, PGE Group said.



The energy storage market in Poland is "not an undersupplied one", has higher financing costs and there is a two-year window in which you need to get in to capitalise on the opportunities, said renewable energy developer and IPP Aquila Clean Energy. DRI, the EU renewables arm of Ukrainian private energy group DTEK, has completed the acquisition of a 133-MW/532-MWh battery energy storage system (BESS) project in Poland from local developed Columbus Energy. Storage . Poland has a small capacity of energy storage that consist mainly of pumped hydro (1.7 GW and 7.6 GWh in 2020), that is used by the TSO mainly for system balancing. There is limited deployment of battery storage in Poland with total battery storage capacity reaching around 9 MW and 33 MWh in 2020.

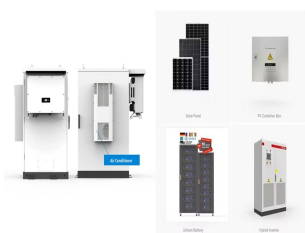

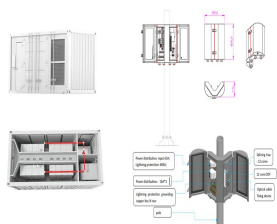

The Poland arm of UK-based developer Harmony Energy is looking to bid in around 500MW of battery storage projects into the upcoming capacity market auction, executive director Michał Maćkowiak said.



Northvolt to invest \$200 million in Greenfield factory project tooled for assembly of cutting-edge, sustainable energy storage systems. The 50,000 sqm factory will be established in Gdańsk, Poland.



PGE is also developing a battery energy storage facility at the Żarnowiec pumped storage power plant (southern Poland) with a capacity of at least 200 MW and a storage capacity of over 820 MWh, planned for commissioning in 2027. By 2030, the company aims to have at least 0.8 GW of new energy storage capacity.

The Norwegian energy storage market is expected to grow from 38 MW in 2023 to 179 MW in 2030, on a smaller scale. Hydropower accounts for 90%, and 1.4 GW of micro pumped hydro storage capacity has been installed, with limited demand for battery energy storage.
