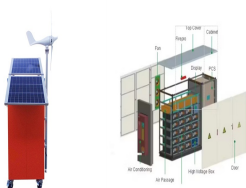

With respect to the onshore renewable energy sources, the support for in Poland has been stimulated by two major support mechanisms: certificates of origin and the auction system. Certificates of origin (green certificates), issued by the President of the ERA, confirm the generation of electricity by a renewable energy source.

A July notice announced that pumped-storage hydropower (PSH) projects are now eligible to issue and trade GECs. PSH stores excess renewable energy by pumping water to higher elevations, releasing it to generate electricity when needed.



Local media previously reported that Greece's REGOs register will be linked with those of other European countries, enabling domestically-issued green energy certificates to be visible at all European markets signed up to the Association of Issuing Bodies (AIB).



The National Energy Administration issues unique electronic certificates, called green certificates, based on grid energy of green power. Green certificate trading is founded on the renewable portfolio standard, which mandates power generation entities to consume a specific percentage of renewable energy power generation [10], [11]. TAX FREE

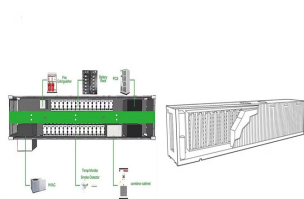

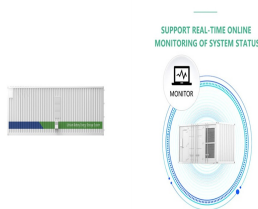
