PV module manufacturer Trina Solar has deployed its first energy storage project in Italy, for its project development arm. Subsidiary Trina Storage has commissioned the 9.3MWh battery energy storage system (BESS) project in Torre di Pierri, Italy, in the province of Taranto, southeast Italy.
