What is FuelCell Energy doing to help the nuclear industry? In 2018, FuelCell Energy earned a \$1.5 million research grant from the U.S. Department of Energy (DOE) to develop the company???s fuel cell technology to aid the nuclear industry by converting excess power back into hydrogen.



When did FuelCell Energy become a company? From the 1970s to 1990s, with sponsorship from U.S. military and other utility companies, the company extended to low-temperature fuel cell area and high-temperature carbonate fuel systems, which proved to have greater potential in commercial applications. It completed its IPO in 1992and was renamed as FuelCell Energy, Inc.



What can FuelCell do for You? FuelCell provides on-site power generation, combined heat and power, distributed hydrogen, carbon capture and hydrogen-based long duration storage. What happened to FuelCell? In November 2018, FuelCell acquired a 14.9-MW fuel cell project in Bridgeport, Connecticut from Dominion Energy for \$37 million. FuelCell had developed, built and been operating the plant since 2013.
