What is the annual Environmental Statement for Harbour Energy plc (harbour)? Annual Environmental Statement 2021 This is the annual environmental statement for Harbour Energy plc (Harbour) for 2021, as required by OSPAR Recommendation 2003/5. The statement covers offshore installations operated by the company in the UK North Sea and installations owned and operated by third parties while providing services to us.



What is Harbour Energy doing in the UK? Harbour also has significant ongoing decommissioning activities in the UK, currently focused on the southern and central North Sea areas. Harbour Energy's AELE hub consists of the operated assets of Armada, Everest and Lomond (and the non-operated Erskine high pressure/high temperature gas field).



Is harbour achieving net zero emissions by 2035? Harbour has committed to the goal of net zero for our gross operated Scope 1 and 2 CO<sub>2</sub> equivalent (CO<sub>2</sub>e) emissions by 2035, with an interim target of 50 per cent reduction by 2030 against our 2018 baseline.



Who is harbour oil & gas? Harbour was formed in 2021 through an all-share merger between Chrysaor and Premier Oil. We are now the largest London-listed independent oil and gas company. We have a global portfolio with a leading position in the UK and multiple international growth options.



What is West Burton energy doing to clean up a refinery-led cluster? West Burton Energy in Nottinghamshire has entered into a partnership with Viking CCS, the Harbour Energy scheme looking to clean up the refinery-led cluster. The independent power generation company operates a combined cycle gas turbine plant - West Burton B - with a capacity of 1.3GW.
