What is military reserve pay? Military reserve pay is available for reserve officers and enlisted soldiers. While you???re serving your weekends and other training duties,you???ll receive pay based on the number of drills you complete. Pay is typically issued on the first and 15th of each month.



What is military reserve drill pay? Reserve pay is one of the many benefits of being in the military reserves. If you???re a National Guard or a Reserve Soldier who???s performing drilling and other training duties, you can receive compensation in the form of military reserve drill pay.



How do reserve soldiers get paid? Reserve soldiers earn regular paychecksfor monthly unit training and annual field training exercises in addition to their civilian income. This list only accounts for annual drill pay,or base pay,and doesn't include bonus pay or other benefits:



Do reserve members get regular drill pay? In return reserve members receive regular drill payand other benefits. If you are serving as a member of the Selected Reserve, you are eligible for regular drill pay, and might qualify for some special pays. Each "Drill Weekend" counts as 4 Drill Periods for pay purposes. Check out the Drill Pay Charts to see how much you could earn each month.

Do reservists get paid? Army Reserve soldiers receive compensationfor both monthly unit training and annual field training exercises, and as illustrated in the above section, their pay increases as they climb in rank and experience. While serving, reservists have many options when it comes to the jobs they can hold.



The National Guard and Reserves advertise a service commitment of One Weekend a Month, Two Weeks of Year. This is a guideline, not a rule. Federal law limits the number of inactive duty points you can ???



In addition to income, Navy Reserve Sailors can plan for retirement through participation in the tax-deferred Thrift Savings Plan (TSP). They can also ensure their family's well-being through Service Member's Life Insurance (SLGI) policy of \$500,000 for just \$29/month, \$100,000 for spouses and \$10,000 for each child.



Each year-long mobilization would earn at least another 365 points. By serving "a weekend a month, two weeks a year" over their other 10 "good years", they can conservatively be expected to average another 75 points each year. These are average numbers, some Reservists will earn more points, some will earn less.

It does make a difference that you have a BS, that would make you a specialist (E-4, three ranks above a private). One thing to consider is Texas has tuition assistance if \$4500/yr. On top of that, you can earn one point a day for any active duty assignment and one point for each 4-hour period of IDT completed. For IDT, you can earn a maximum of 2 points per day. You can apply for ADSW and ADT with a DA Form 1058. Most IRR members earn points by completing correspondence courses, but they are not always easy to come by and



Federal law limits the number of inactive duty points you can earn each retirement year. Reserve year ends on or after 30 Oct 2007: max of 130 Points; Reserve year ends on or after 29 Oct 2000: max of 90



If you are in the National Guard or the Reserve, you earn points toward retirement while serving part-time and when called to active service. You qualify for military retirement as a member of a Reserve Component once you have reached 20 creditable years of military service. The proposed Defense Budget includes a 3.0% pay raise for all military members, including members of the Guard and Reserves.
