By far the most dominant battery type installed in an energy storage system is lithium-ion, which brings with it particular fire risks.

What happens if a power generation & energy storage facility fires? Power generation and energy storage fires can be very costly, potentially resulting in a total write-off of the facility. Fires happen quickly and may spread fast, destroying critical company assets. Passive fire protection may lower risk but ignition sources and fuel supplies remain.
