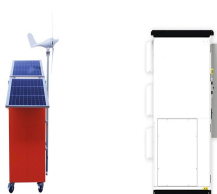

How much electricity does Lesotho produce? Lesotho produces about 72 MW from hydropower (Meula). It has about 150 MW peak power and imports more than 70 MW mainly from Mozambique (29% of peak demand) and 20% of its peak demand from South Africa. The electricity supply accounts only for +50% in the energy mix.

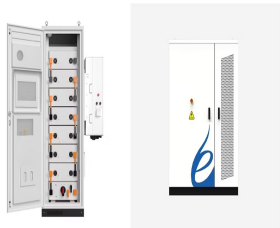

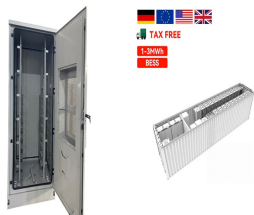
