How can Liberia improve energy security? One strategy is to diversify the energy mix by increasing the share of domestic renewable energy sources, such as solar and wind power, for electricity generation. By harnessing these indigenous and sustainable energy resources, Liberia can decrease its reliance on imported fuels and enhance its energy security.



What energy sources does Liberia use? Liberia also utilizes other energy sources on a smaller scale. These include small-scale renewable energy systems such as solar and biomass. However, the contribution of these sources to the overall energy mix in Liberia is limited. Abundant and clean energy sources, reducing reliance on fossil fuels.



Is electricity available in Liberia? In Liberia, the availability of grid-connected electricity is limited, which has one of the world's lowest electricity consumption rates with <50 kWh per capita per year. As shown in Fig. 8, it was estimated that only about 28 % of the population has access to modern electricity.



What are the challenges to energy access in Liberia? The primary challenge to energy access in Liberia is the limited and underdeveloped energy infrastructure. The lack of adequate power generation, transmission, and distribution systems contributes to this low access rate. The electrification rate is significantly lower in rural areas, where most of the population resides.



How much energy does Liberia produce a year? Liberia also has abundant biomass resources, with estimates suggesting that the government can produce up to 27,452 GWh of electricity from biomass annually. Expanding these resources can provide sustainable and decentralized energy solutions, particularly in rural and remote areas.
