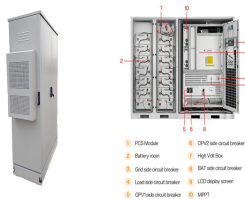

Actually the most of the Magdalen islands were settled by catholic acadians from Miquelon who fled the French revolution : they believed the king was of divine right, therefore a Republic was antithetic to their beliefs.

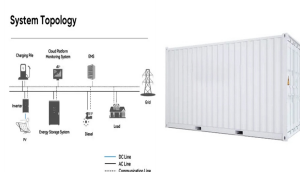
