Does the Marshall Islands have electricity? Electricity Sector. MEC and KAJUR supply all electricity. The Marshall Islands has no electricity law or regulator and no private generators licensed to sell electricity. Its electrification rate is approaching 100% based on the number of on-grid and off-grid customers and the average household size of 6.8 persons.



How does Marshalls Energy Company pay a project? All project payments are in the form of checksfrom the renewable energy account and require two approved signatories,one each from MEC and the Min. of R&D. Marshalls Energy Company is audited every year by the international Auditing Firm Deloitte and the accounts for this program will be included as part of the annual MEC audit operation.

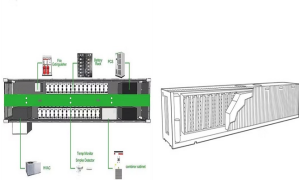
