The principal downstream enterprises are based in the UK and include Drax Power Limited,which runs the biomass fuelled Drax power station,near Selby in North Yorkshire. The Group also runs an international biomass supply chain business.



Why is Drax Power Station important? Drax Power Station has a long,proud history of playing a central role in producing the UK???s electricity. It is already the home of the largest decarbonisation project in Europe and is now the site of innovation for bioenergy with carbon capture and storage (BECCS),a negative emissions technology essential for fighting the climate crisis.



Where is Drax based? The principal downstream enterprises are based in the UKand include Drax Power Limited, which runs the biomass fuelled Drax power station, near Selby in North Yorkshire. The Group also runs an international biomass supply chain business. The company is listed on the London Stock Exchange and is a constituent of the FTSE 250 Index.



Why is Drax the UK's largest power station? Drax doubles in size and capacity to just under 4 GW, becoming the largest power station in the UK. Drax becomes the first power station to invest in retrofitted flue gas desulphurisation (FGD) equipment. Once fully operational in 1995, it removes 90% of sulphur dioxide emissions, making it the cleanest coal-fired power station in the UK.



How big is Drax Power Station? Drax Power Station is officially opened with three generators and a total electrical capacity of just under 2 gigawatts (GW). It has the capability to power around two million homes. Drax doubles in size and capacity to just under 4 GW, becoming the largest power station in the UK.

Who owns Drax Power Station? In 1990, the electricity industry of England and Wales was privatised under the Electricity Act 1989. Three generating companies and 12 regional electricity companies were created. As a result of privatisation, Drax Power Station came under the ownership of National Power, one of the newly formed generating companies.



Drax Power Station is the single largest producer of electricity in the UK and the largest biomass power plant in the world, its supply chain extending deeply into American forests. This article ???
