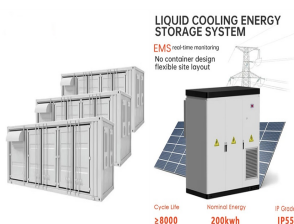
Gas production was 1.5trn scf in 2014, with two companies, BP Trinidad and Tobago (BPTT) and BG Group Trinidad and Tobago (BGTT) accounting for roughly three-quarters of total gas production. In early 2016 Royal Dutch Shell completed its global takeover of BG Group, and BGTT was rebranded as a Shell subsidiary.

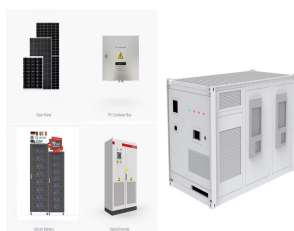
