Will EQT Infrastructure buy Covanta? EQT Infrastructure,a Swedish private equity firm,plans to acquire all shares of Covanta's stockat a price of \$20.25. The transaction (including net debt) is valued at \$5.3 billion and could close during the fourth quarter of this year,pending regulatory approval.





When will Covanta expand its waste-to-energy facility? Asked for a possible timeline on expanding existing U.S. facilities or building new ones, Veenhof projected it could be within the next five to seven years. Covanta currently has 41 waste-to-energy facilities in North America and Europe, with a team of nearly 4,000 people managing an estimated 21 million tons of waste per year.


