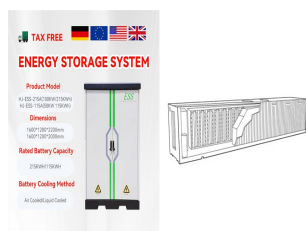

The Bosniak-Croat conflict ended in March 1994, with the signing of the Washington Agreement, leading to the creation of a joint Bosniak-Croat Federation of Bosnia and Herzegovina, which amalgamated HVO-held territory with that held by the Army of the Republic of Bosnia and Herzegovina (ARBiH).

Bosnia and Herzegovina is politically fragmented, and so is the memory landscape within the country. Narratives of the 1992-1995 war, the Second World War, Tito's Yugoslavia, and earlier historical periods form highly disputed patterns in a memory competition involving representatives of the three "constituent peoples" of Bosnia and Herzegovina - Serbs, Croats, and Bosniaks.



In Bosnia and Herzegovina we focus on supporting restructuring and expansion of the local private sector, forging closer linkages with wider regional markets and promoting a more efficient and sustainable use of resources whilst continuing to coordinate the EBRD's activities with the EU and IFI partners.

The U.S. has been a strong partner and friend of BiH for the past 25 years, providing about \$2 billion in assistance since 1995 to support reconstruction, humanitarian assistance, modernization of the defense sector, economic ???



The internationally brokered Dayton Accords???the peace agreement negotiated in Dayton, Ohio, U.S., in November 1995???established Bosnia and Herzegovina as a state composed of two highly autonomous entities, the Republika Srpska (Bosnian Serb Republic) and the Federation of Bosnia and Herzegovina. The latter is a decentralized federation of Croats ???



The first state in modern-day Bosnia and Herzegovina was in the Middle Ages. After the conquest of Bosnia by the Ottoman Empire in the 15th century, Islam was introduced to the local population. During the Ottoman Empire, it was a very important province in the Balkans and the capital, Sarajevo, had 100,000 people the Russo-Turkish War (1877???1878), Austria-Hungary ???
