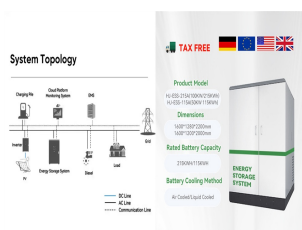

Mainstream Energy Solutions Limited (MESL) was established in 2011 and licensed as a power-generating company. Through a concession agreement with the Federal Government of Nigeria, MESL acquired the Kainji and Jebba Hydro Plants (HPP) in November 2013, with a combined installed capacity of 1,338.4 MW.



A penstock is a pipe that conveys the flow from the forebay to the turbine. The penstock pipe starts downstream of the forebay where the ground profile is much steeper than the headrace alignment. The potential energy of the water at the forebay is converted into kinetic energy at the turbine
