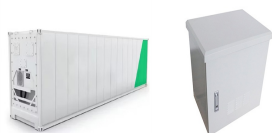




The NEM Programme has been in place for some time, wherein domestic users with installed solar PV systems in their respective residences are encouraged to utilise the solar energy generated by the panels and to supply the excess energy back to the TNB for the purpose of obtaining NEM credit.




Under the new regulatory regime, IUPTLU holders must establish a five-year quota for development of Rooftop Solar PV systems in Indonesia. 
