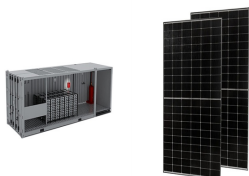


How do I record a patent assignment? So the patent owner (the Assignee) should should record the assignment through the USPTO's Assignment Recordation Branch. They can use the Electronic Patent Assignment System (EPAS) to file a Recordation Cover Sheet along with a copy of the actual patent assignment agreement.

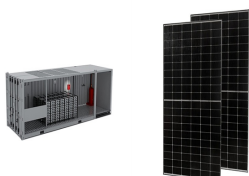


How do I file a patent assignment with the USPTO? Once the document has been completed, both parties should sign the document in front of a notary and have the notary complete the notary page. The document must then be recorded with the USPTO within three months of its signing, or it becomes void. The current cost for filing an assignment with the USPTO is \$40 per patent.

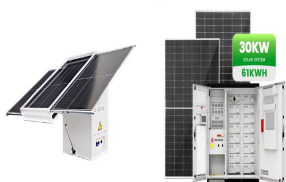
