a. Freedom of Speech and Press. Moroccan law and practice apply. The constitution and law generally provide for freedom of speech and press, although criticism of Islam, the institution of the monarchy, or the government's official position regarding territorial integrity and claim to Western Sahara is considered criminal and therefore restricted.



A former Spanish colony, Western Sahara sits on the western edge of the vast eponymous desert, stretching along the Atlantic coast. When Spain withdrew in 1975, Morocco sent thousands of people across the border and claimed it was an integral part of its territory.



"This is a momentous victory for the people of Western Sahara. At a time when international law is under pressure, it is fundamental that the EU follows its own court and stops collaborating with the occupier through illegal trade agreements", stated Western Sahara Resource Watch. This morning, the EU Court of Justice issued a landmark ruling.



The U.N. envoy for Western Sahara, Staffan de Mistura, has floated the idea of dividing the territory between Morocco and the Polisario front as a solution to the near five-decades-old dispute

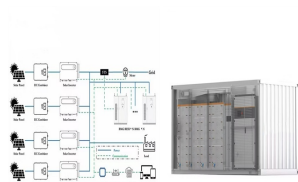
More recently, an attack inside Moroccan-controlled Western Sahara has highlighted the potential for further military escalation. On May 20, an alleged bomb attack reportedly targeted a segment of a 100-kilometer conveyor belt used by Morocco to export phosphates from a mine located deep within Western Sahara to the coast.

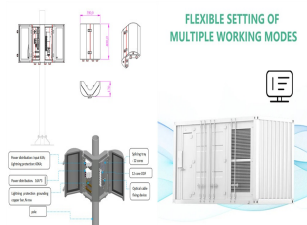

The Kingdom of Morocco claims the territory of Western Sahara and administers the estimated 85 percent of that territory that it controls. The Popular Front for the Liberation of Saguia el Hamra and Rio de Oro (POLISARIO), an organization that seeks the territory's independence, disputes Morocco's claim to sovereignty over the territory.
