Spanish independent power producer (IPP) Sonnedix has commissioned its 150MW Betierra solar portfolio in Spain, bringing the company's total renewable energy capacity in the country in operation



The projects will be supported by a ten-year power purchase agreement (PPA) with an undisclosed international technology company. Elmya and Metlen have been appointed as the engineering, procurement and construction (EPC) contractors for the solar projects, while LONGi has been selected to supply the solar modules.



The plant remained offline for nearly 5 months, while grid repairs were implemented, and production was limited to less than 45 percent of its energy capacity once reenergized.
