

# US OUTDOOR ENERGY STORAGE ANTI-DUMPING DUTIES



What's new in anti-dumping and countervailing duty regulations? The US Department of Commerce (DOC) has released a final regulation aimed at enhancing the anti-dumping and countervailing duty (AD/CVD) regulations. This ultimate decision closely follows the DOC's proposed rules from May 2023, with slight adjustments intended to bolster the enforcement and management of the AD/CVD laws.



Why did the American active anode material producers file antidumping and countervailing duty petitions? The American Active Anode Material Producers filed antidumping and countervailing duty petitions on Dec. 18, 2024, with the U.S. Department of Commerce and International Trade Commission to address alleged unfair imports of active anode material from China, with claimed dumping margins of 828 percent and 921 percent.



What are antidumping and countervailing duties? Antidumping and countervailing duties are intended to offset the value of dumping and/or subsidization. They help level the playing field for domestic industries injured by unfairly traded imports.



What is a dumping investigation? Under U.S. law, domestic industries can request AD investigations to determine whether imported products are being sold in the U.S. at less than fair value, known as "dumping." They can also seek CVD investigations to examine whether foreign producers are receiving unfair subsidies from their governments.



What if duties are imposed on imported lithium-ion batteries? If duties are imposed, the active anode material portion in imported batteries will be affected, but only the active anode material in imported lithium-ion batteries from China (rather than the entire value of the batteries) will be subject to these duties.

What is dumping? Dumping occurs when a foreign producer or exporter sells a product in the United States at a price that is below "normal value". (The term "normal value" refers to the price that would be charged for the product in its home market or in a third country.)
