The sawmill was soon taken over by industrialist Nils Ludvig Arppe,who built ironworks in the premises. In 1898 the company was renamed W?rtsil? Ab.

Year on year Wartsila Oyj Abp had relatively flat revenues (5.84bn to 6.02bn), though the company grew net income from a loss of 65.00m to a gain of 257.00m. A reduction in the cost of goods sold as a percentage of sales from 39.46% to 34.30% was a component in the net income growth despite flat revenues.
