

# WHAT INVOICES SHOULD BE ISSUED FOR ENERGY STORAGE BUSINESS



What should be included in an invoice? An invoice should always include a complete description of any items or services purchased including the purchase date, the number of items purchased, or the type of service purchased. Each item or service purchased should be listed as a separate line item.



What are invoices used for? Invoices are used for various purposes, depending on whether you are the buyer receiving the invoice or the seller providing the invoice. Buyers use invoices to document a purchase, even if a purchase order is used. The invoice is used to verify the terms of the purchase, including the number and type of products or services purchased.



What are the requirements for developing electronic invoice information system? Article 32 Developing electronic invoice information system to offer tax-related services such as data search, download, storage, and use for others shall comply with the data standards and management regulations of the tax authority, sign an agreement with the client and shall not use invoice data beyond the authorized scope.



What are electronic invoices? Article 3 Electronic invoices mentioned in Article 3 of the Measures, refer to the certificates of receipts and payments in the form of electronic data showing the purchase and sale of goods, the provision or acceptance of services, and other business activities in accordance with the administrative regulations of tax authorities.



How do businesses receive invoices? Businesses receive invoices through various channels such as email, postal mail, or vendor portals. Ensuring a standardized intake process prevents invoices from getting lost or delayed. 2.

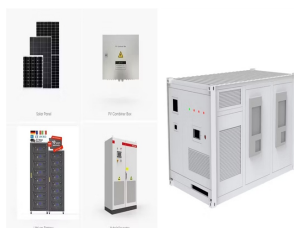
